## 1-800-DIG-SAFE

Summer is usually the time when extra outdoor activity happens, including digging. Kansas Statutes 66-1801 through 66-1814 require that anyone who engages in any type excavation must provide advance notice of at least 2 full working days to the facility owner. To simplify this process, Kansas law created the Kansas One-Call system, administered by the Kansas Corporation Commission. Underground utilities and other operators are required to be paying members of the Kansas Onecall

system. **KCC** penalties and civil damages may apply to excavators who do not follow the regulations.

In most situations when you're digging or doing other earth work, the procedure is simple: 1) call 800-344-7233 (800-DIG-SAFE); 2) wait the prescribed time, during which all operators in the area will locate their property; 3) respect the markings; 4) dig safely. There is no cost to the excavator. All fees are paid by the facility owner. If we mis-locate or fail to locate, the excavator is absolved from damages.

To make things even easier, the new Kansas One-Call short cut has been implemented in our service area. 1-800-DIG-SAFE (800-344-7233), can be reached by just dialing 811! Web access: http://www.kansasonecall.com/ has a handy excavator's manual and newsletters.

counties, in town and in country, along roads and across fields, in public rights-ofway and along acquired private easements. This cable is generally well-marked along its routes with highly visible warning signs.

How does the cost of repairing this cable compare to copper cable? Because light travels down this cable, and light is sensitive to any changes in the quality of the glass, these tiny splices must be perfect. The measuring equipment is expensive. Maintenance personnel is expensive. Kits containing the spliced cables are expensive. As a general rule, a fiber optic cable cannot be spliced for less than \$5000! This simple cut, on the front page, just outside Conway Springs in 2003 cost just under \$11,000 to repair. Some locations would be much more expensive to repair, due to the size of the cable. In addition, fiber outages usually effect large numbers of customers.

We will generally seek compensation from excavators who damage our facilities when we have not been notified via the One-call system, or when the excavator ignores our marking.

Excavation exemptions: Agricultural tilling is exempted. Railroad and road maintenance is exempt when the maintenance does not change the existing grade or ditch flow line. Exploration and production for crude oil and natural gas is also exempt. These operations are exempt from the Kansas One-call excavator requirements, but not from civil damages.

One-call membership exemptions: City water and sewer departments are not required to be members of One-call, although some are. Some oil and gas production facilities are also exempt from membership. These operators may need to be contacted individually.

Remember, location markings are estimates and may vary by 24 inches. The only sure way to know a cable's exact location is for us to expose it.

### No More FET!

The Treasury Department and Internal Revenue Service announced May 25th that the IRS will stop collecting the 3% federal excise tax (FET) on long-distance telephone services in light of the government's many court losses on this issue. The IRS released guidance (Notice 2006-50) that redefines nontaxable telephone service to include all long-distance telephone service, bundled telephone services (including situations where local and long-distance charges are combined for both wireless and landline services), prepaid telephone cards, and Voice over Internet Protocol (VoIP) telephone services. The IRS will continue to collect the tax on local-only telephone service. Customers will see that change within the next couple of months.

#### **DSL Speed?**

Popular sites like Youtube need faster Internet speeds. Nearly 2 million people viewed 9-11 plane crash into Pentegon in the 1<sup>st</sup> 24 hours after the clip was posted.
